

## Architect Balkrishna Doshi earns accolade from PM for winning prestigious UK medal

**NEW DELHI, DEC 10** /-/- Prime Minister Narendra Modi on Friday congratulated acclaimed Indian architect Balkrishna Doshi on being awarded the UK's prestigious Royal Gold Medal 2022 and said his contributions to the world of architecture are monumental.

Doshi will receive the Royal Gold Medal 2022, one of the world's highest honours for architecture, the Royal Institute of British Architects (RIBA) announced. "Spoke to the distinguished architect Shri Balkrishna Doshi Ji and congratulated him on being awarded the Royal Gold Medal 2022," Modi tweeted. "His contributions to the world of architecture are monumental. His works are globally admired for their creativity, uniqueness and diverse nature," the Prime Minister said. RIBA said on Thursday that with a 70-year career and over 100 built projects, 94-year-old Doshi has influenced the direction of architecture in India and its adjacent regions through both his practice and his teaching.

Given in recognition of a lifetime's work, the Royal Gold Medal is approved personally by Queen Elizabeth II and is given to a person or group of people who have had a significant influence on the advancement of architecture. Born in 1927 in Pune, to an extended family of furniture makers, Doshi studied at the JJ School of Architecture, before working for four years with Le Corbusier as Senior Designer (1951-54) in Paris and four more years in India to supervise projects in Ahmedabad. He worked with Louis Kahn as an associate to build the Indian Institute of Management, Ahmedabad, and they continued to collaborate for over a decade. (PTI)

taken both the doses are less impacted by the virus. There are cases in some areas where booster doses have been administered... such people experienced mild effects when they got infected," the deputy chief minister said.

Pawar, however, said a decision regarding an additional vaccine dose has to be taken at the Centre's level. "The Prime Minister and the Centre decided to give two doses of vaccines. If any decision to administer a third (booster) dose is taken, according to my knowledge, the Serum Institute of India has the availability of doses.

According to a recent statement from the company, they have reduced the production of the vaccine due to a drop in demand," he said.

The Pune-based Serum Institute of India manufactures Covishield, the mainstay of India's Covid-19 vaccination programme.

He, however, said the government's thrust is to achieve 100 per cent vaccination as far as the second dose is concerned. "Once both the doses are done 100 per cent, we can think about a booster dose and also vaccination for the 12 to 18 age group if the Centre's health department gives permission," said Pawar.

Asked about taking strict stand against those still showing vaccine hesitancy, the minister said

in one district (Aurangabad), the respective collector took some strict measures (like no vaccine, no fuel, and ration) as they were lagging in inoculation rate.

"After that decision, the number of people taking the doses went up. As a government, our job is to convince people but people should also respond positively. But there are people who neither think about their own life nor about others," he said.

"If we do not get a positive response from people on the vaccination front, we may think of taking some strict stand," Pawar said. To increase the pace of vaccination, instructions have been issued to hold special camps and deploy mobile vans to reach out to people, the minister said. (PTI)
